Privacy Policy

GARDECO OBJECTS BV (hereinafter referred to as "GARDECO") is committed to protecting your privacy and providing most comprehensive product / company information and safe online experience. This Privacy Statement applies to the GARDECO website www.gardeco.eu & the GARDECO Web Shop www.gardeco.eu/onlineshop (both referred to as 'Website') and administrates data collection and usage. We respect your privacy and adhere to the rules set by the AVG/GDPR. Our employees and third parties engaged by us are obliged to respect the confidentiality of your data.

By using the Website, you consent to the data practices described in this Privacy Policy.

Processing of personal data

By using this Website, you agree that the personal data collected via the Website will be processed in accordance with this Privacy Policy. Your personal data which this **Website** may collect includes:

- information collected when you enter or use our Website of Web Shop, register or update an online profile, which is required by us in order to process any orders and therefore may include personal data such as your name and contact details as your email address, name, work address, invoice details or telephone number;
- the content of electronic forms you submit via this Website, requesting us to provide services or information, or take actions;

- Information required for legal purposes

You may browse some information-only areas of this Website without providing any personal data, however we may not be able to provide the full range of services through this Website or Web Shop if we are not provided with the information outlined above.

Next to the personal data, we may also collect non-personal data. This type of information tells us more about which pages you visit on this Website and the address/location of the site you were using in order to visit this Website. Please note that this information is analytical

and will not be used to identify or contact you individually, but it is used to help to administer and improve the Website.

Besides via the Website, we may collect data from and about you **via other methods**, such as direct interactions. You may give us your Identity and Contact by exchanging business cards, by filling in forms or by corresponding with us by post, phone, email or through chat or social media.

This includes personal data you provide when you:

- sign up to receive the GARDECO newsletter;
- make enquiries or request information to be sent to you;
- order our products or services;
- ask for marketing to be sent to you;

- contact customer services; or
- leave comments or reviews on our products or services (please be kind!).

Use of your Personal Information

GARDECO Websites will disclose your personal information, without notice, only if required to do so by law or in good faith and belief that such action is necessary to: (a) conform to the applicable laws and regulations, and/or to comply with legal process served on GARDECO or the Site; (b) to protect and defend the rights and properties of GARDECO; and, (c) to act under urgent circumstances in order to protect the personal safety of Customers, users of the GARDECO website or Web Shop, or the public interest.

We may use the following third-party service provider to process and store your data:

- Mailchimp, which we use to manage email marketing subscriber lists and to send emails to our subscribers.
- Salesforce CRM, which we use to store your personal data received via the means as mentioned above.

GARDECO does not sell, share, trade or give away Personal Information other than as described in this Privacy Policy;

GARDECO keeps track of the Websites and pages our customers visit within GARDECO, in order to determine what GARDECO services are most appealing to the general audience. This data is used to deliver customized content and advertising within GARDECO to customers whose behaviour indicates that they are interested in a particular subject area.

You always have the option and the right to inspect your data. You have the right to view, correct or delete your personal data. To this end, you can send a specified request to GARDECO by sending an e-mail to the e-mail address as stated below under 'contact information', stating your name and address. In the event of a request for removal, GARDECO will remove the personal data concerned as soon as possible, unless and insofar as the law obliges to keep the relevant personal data or there are (other) urgent reasons that oppose removal.

Use of Cookies
